The quotes were discussed. Members of the public asked if a larger activity tower could be installed. It was agreed that Ludus (Lappset) would need to be contacted to see if this tower would fit onto the existing wetpour surface. If the unit would not fit there would be an additional cost of extending the current surfacing. Ludus (Lappset) would also be asked to provide a quote for supplying the larger tower.

Mrs Pyne reported that, as the deadline to apply for a grant of £5,000.00 was within one week, the quotes for the smaller tower, which would fit on to the existing surface, would have to be used in the application and a decision about what tower to buy could be made at a later date. It was agreed that further fundraising would be needed and a number of events were discussed.

Mrs B Mann reported that the Lions Club might be prepared to donate. Clerk to contact the Chairman of the Lions Club.
